Call to Order: A meeting of the Alpena County Library Board of Trustees was called to order on Wednesday, September 15, 2021 at 4:00 p.m. by President Joseph Garber.

Minutes: It was moved by Cornish with support from Meneghel to approve the Minutes as corrected from the August 18, 2021 Regular Board Meeting. The motion passed.

Treasurer's Report: The Treasurer's Report was reviewed and Garber directed that it be filed as presented, subject to final audit.

Review and Approval of Bills: It was moved by Hunter with support by Meneghel that bills as presented be approved. The motion passed.

Old Business:

- **A. Employment Policy Review:** Staff comments along with Magness-Eubanks' responses to the comments were distributed. The personnel committee will meet with Luther and DeCaire to review the comments and present their recommendations to the Board for tentative approval at the October Meeting.
- **B.** Building Project and Hours after Reopening Schedule: A timeline of activities related to moving back and reopening of the Library along with proposed operating hours was reviewed. It was moved by Hunter with support from Cornish to establish the following hours when full service is resumed: Monday-Thursday 9:00 a.m.-8:00 p.m., Friday 9:00 a.m.-7:00 p.m., Saturday 9:00 a.m.-4:00 p.m. and Sunday 1:00 p.m.-5:00 p.m. During the summer months, the Library will be closed on Sundays between Memorial Day and Labor Day. The motion carried.
- C. Resolution to Request Payment of Building Project Bills: A resolution was presented for Board approval to direct the Alpena County Building Authority to pay bills related to the construction project in the amount of \$312,501.32. It was moved Meneghel with support from Cornish to approve the resolution. The motion passed. A copy of the signed full resolution is attached.
- D. Resolution to Request Payment of Bond: A resolution was presented for Board approval to make a scheduled bond payment due November 1, 2021 in the amount of \$33,025. It was moved by Meek with support from Hunter to approve the resolution. The motion passed. A copy of the signed full resolution is attached.

- E. Special Collections Donation: It was moved by Hunter with support from Cornish to instruct Magness-Eubank and LaBarre to proceed to obtain a written gift agreement to present to the Board. The motion passed.
- **F.** Surplus Property: Magness-Eubank stated that Corrigan will assist with the removal of items deemed as scrap.
- G. 2021 Budget Amendment: An amended budget with total income and expenses of \$2,202,157 each was presented to the Board. It was moved by Hunter with support from Meneghel approve the amended budget. The motion passed. A copy of said budget is attached. Due to increased operating costs, Hunter suggested looking into tax revenue being captured by the Downtown Development Authority. Magness-Eubank will give an update at the next meeting.

Development Report: The written report was reviewed.

Friends of the Library Report: Grochowski shared that they are working on a fundraising opportunity with Family Enterprise Inc. to launch a temporary online store that will offer shirts with the FOL logo.

Adjournment: President Garber declared the meeting adjourned at 5:07 p.m. The next regular meeting will be Wednesday, October 20, at 4:00 pm.
